FOR USE WITH VARIOUS MANUFACTURERS NIGHT VISION MONOCULARS, THERMAL CAMERAS, OR CURRENTLY FIELDED DAY-SIGHT MAGNIFIERS

USING PWWM-S POSITIONS THE SUPPORTING OPTIC TO THE TYPICAL HEIGHT REQUIREMENTS OF DAY SIGHTS (1.55" TYPICAL) FOR CONCENTRIC VIEWING.
